OFFICIAL PROCEEDINGS CITY OF MORGAN CITY AUGUST 25, 2020

The Mayor and City Council of Morgan City, Louisiana, met at 6:00 pm (local time) in regular session, this date, in the Morgan City Municipal Auditorium Theater, 725 Myrtle Street, Morgan City, Louisiana.

There were present: Honorable Frank P. Grizzaffi, III, Mayor; and Council Members Ron Bias, Steve Domangue, Tim Hymel, Mark Stephens, and Louis J. Tamporello, Jr.

Absent: None

Also present were Mr. Marcus Folse, Chief Administrative Officer and Mr. Paul Landry, City Attorney.

The invocation was given by Pastor Tommy Fromenthal.

There was no positive image recipient for the month of August.

Mr. Clarence Robinson with the Morgan City Housing Authority presented the PILOT payment to the Mayor and Council. He thanked the City for all of their cooperation.

Mr. Lee Dragna addressed the Mayor and Council to announce his candidacy for Mayor of Morgan City.

Ms. Lori Landry addressed the Mayor and Council to announce her candidacy for District Attorney, 16th Judicial District.

Beth Portero and Jonathan Price submitted a proposal to hold the Mistletoe and Moss Holiday Market (copy on file). They sated it would be under the bridge on November 28, 2020. A motion to allow the Mistletoe and Moss Holiday Market was made by Mr. Stephens, seconded by Mr. Domangue, and voted unanimously in favor.

Ms. Marcelle Hoskins addressed the Mayor and Council to announce her candidacy for Morgan City Council, District 3.

The minutes of the July 28, 2020 meeting were submitted. There being no corrections, additions, or deletions, a motion to approve the minutes was made by Pastor Bias, seconded by Mr. Hymel, and voted unanimously in favor.

Mrs. Deborah Garber, Finance Director, submitted the following financial statement for the period ending July 31, 2020.

Attached is a summary that compares our actual revenues and expenses to our operational budget for our major funds subject to budgetary control for the period ending July 31, 2020. The following comments are related thereto:

General and Ancillary Funds: Revenues are now slightly over budget by \$11,700. Sales taxes in General Fund are over budget by \$101,000. Revenues in the Auditorium, Lake End Park, Parkway and Recreation are all considerably under budget by a combined total of 147,800 due to COVID-19. Operating expenses are below budget by \$479,500. The net loss, after transfers, of \$1,227,900 is a favorable variance of \$491,200 compared to the budget.

<u>Utility Fund</u>: Actual revenues continue to be increasingly under budget by \$1,671,00, with operational expenses comparably under budget by \$1,558,00. The net income, after transfers, of \$322,300 creates an unfavorable variance this month right at \$115,000.

<u>Sanitation and Sewer Fund</u>: The operating revenues are \$54,500 over budget, with total operating expenses under budget by \$140,000. The net income, after transfers, of \$564,300 leaves a favorable variance this month of \$195,000.

ORDINANCE NO. 20-06

AN ORDINANCE FIXING THE RATES OF TAX TO BE ASSESSED BY THE MUNICIPAL CORPORATION OF MORGAN CITY, LOUISIANA, FOR THE CALENDAR YEAR 2020.

BE IT ORDAINED, by the City Council, the governing authority of the City of Morgan City, Louisiana, in regular session convened:

SECTION 1

That the tax roll of the City of Morgan City as prepared by the St. Mary Parish Assessor, showing the assessed value of all property subject to taxation within the said City, on said roll, to amount to the sum of ONE HUNDRED TWENTY SEVEN MILLION, NINE HUNDRED THOUSAND, FOUR

HUNDRED SEVENTY FOUR and no/100 DOLLARS (\$127,900,474) to be and the same is hereby ratified and approved by this body.

SECTION 2

That for the purpose of paying the maintenance and other such expenses of the Municipal Auditorium for the year 2020, there is hereby levied a tax of TWO (2.0) mills on the dollar upon the assessed value of ONE HUNDRED TWENTY SEVEN MILLION, NINE HUNDRED THOUSAND, FOUR HUNDRED SEVENTY FOUR and no/100 DOLLARS (\$127,900,474).

SECTION 5

That the City Tax Collector of the City of Morgan City, Louisiana, be and he is hereby authorized, empowered, and directed to make the collection of the taxes imposed for and on behalf of said City, according to law; that the taxes herein levied shall be a permanent lien and privilege on all of the property subject to taxation as herein set forth; and the collection hereof shall be enforceable in the manner provided by law.

SECTION 6

That all ordinances or parts of ordinances in conflict hereby be and the same are hereby repealed and this ordinance shall take effect upon its adoption, the public welfare so demanding.

Mr. Tamporello seconded the motion.
