OFFICIAL PROCEEDINGS CITY OF MORGAN CITY NOVEMBER 16, 2015

The Mayor and City Council of Morgan City, Louisiana, met at 6:00 pm (local time) in regular session, this date, in the City Court Building, Highway 182 East, Morgan City, Louisiana.

There were present: Honorable Frank P. Grizzaffi, III Mayor; and Council Members Ron Bias, Barry Dufrene, James Fontenot, and Louis J. Tamporello, Jr.

Absent: Tim Hymel

Also present were Mr. Marcus Folse, Chief Administrative Officer and Mr. Paul Landry, City Attorney.

The invocation was given by Reverend Terry Bunner, New Life Tabernacle.

Mr. Pat Cloutier addressed the council regarding the street flooding during the recent rain event. He stated that at the Consolidated Drainage District meeting there was no media present to hear the Mayor's side of the story and he thought that the Mayor should advise the media that the pumps were turned on by the City in a timely manner. Mayor Grizzaffi stated that he would speak with the Daily Review.

The minutes of the October 27, 2015 meeting were submitted. There being no corrections, additions, or deletions, a motion to approve the minutes was made by Mr. Tamporello, seconded by Mr. Dufrene, and voted unanimously in favor.

Mrs. Deborah Garber, Finance Director, submitted the following financial statement for the period ending October 31, 2015

Attached is a summary that compares our actual revenues and expenses to our operational budget for our major funds subject to budgetary control for the period ending October 31, 2015. The following comments are related thereto:

<u>General and Ancillary Funds</u>: Actual total revenues are over budget by \$166,000. Sales taxes in General Fund were under budget by 416,500. Operating expenses are below budget by \$536,800. The net income, after transfers, of \$433,777 creates a favorable variance of \$702,800.

<u>Utility Fund</u>: Actual operating revenues are under budget by \$217,000, with operational expenses under budget by \$1,493,000. Energy and gas costs are \$1,100,000 under budget. The net income, after transfers, of \$882,450 creates a favorable variance of \$1,601,100.

<u>Sanitation and Sewer Fund</u>: The operating revenues are \$23,600 under budget, with total operating expenses also under budget by \$27,400. The net income, after transfers, of \$272,400 leaves a favorable variance of \$24,300.

ORDINANCE NO. 15-10

AN ORDINANCE OF THE CITY COUNCIL OF MORGAN CITY, LOUISIANA ADOPTING AN OPERATING BUDGET OF REVENUES AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2016, AND ENDING DECEMBER 31, 2016.

SECTION 1

BE IT ORDAINED, by the City Council, the governing authority of the City of Morgan City, Louisiana, that:

Section 1

The attached detailed estimate of revenues as reflected in the consolidated statement, the supporting line item budget, and other such fiscal exhibits and information as required by the Louisiana Local Government Budget Act are ready for approval and adoption to serve as the Budget of Revenues for the City for the Fiscal Year January 1 to December 31, 2016.

Section 2

The attached detailed statement of expenditures as reflected in the consolidated statement, the supporting line item budget and other such fiscal exhibits and information as required by the Louisiana Local Government Budget Act are ready for approval and adoption to serve as the Budget of Expenditures for the City for Fiscal Year January 1 to December 31, 2016.

Section 3

The adoption of the Budget of Expenditures as reflected in the attached line item budget containing account object of expenditure classifications shall be declared to be the appropriation of the amounts set therein as established in each budget classification by object of expenditure.

Section 4

The amounts appropriated for all accounts shall not exceed the amounts fixed therefore in the Budget of Expenditures; however, nothing contained in this section shall be construed to prohibit the governing authority from amending or making an appropriation to and for a contingent fund to be used in cases of emergency.

BE IT FURTHER ORDAINED, etc., that the budget for fiscal year January 1 to December 31, 2016, as attached hereto and made a part hereof be and the same is hereby approved.

Should any section, paragraph, sentence, clause, or phrase be declared unconstitutional or repealed for any reason, the remainder of the ordinance shall not be affected hereby. That all laws or parts of laws in conflict with this ordinance be and the same are hereby repealed. This ordinance shall take effect immediately after its passage within the time prescribed by law.
