OFFICIAL PROCEEDINGS CITY OF MORGAN CITY MAY 24, 2022

The Mayor and City Council of Morgan City, Louisiana, met at 6:00 pm (local time) in regular session, this date, in the City Court Building, Highway 182 East, Morgan City, Louisiana.

There were present: Honorable Lee Dragna, Mayor; and Council Members Steve Domangue, Tim Hymel, Mark Stephens and Louis J. Tamporello, Jr.

Absent: Ron Bias

Also present were Mr. Charlie Solar, Jr., Chief Administrative Officer and Mr. Paul Landry, City Attorney.

The invocation was given by Mark Stephens.

The Positive Image recipient for the month of May was Mr. Paul Cheramie. Councilman Domangue stated that Mr. Cheramie lived near Lawrence Park and had been taking care of the water fountain in the park for many years and his time and efforts did not go unnoticed.

District Attorney Bo Duhe' addressed the Council regarding funding for the Acadiana Criminalistics Lab. He stressed the importance of having the lab updated. The lab was awarded Capital Outlay monies, but there was a five-million-dollar match to the funding. He said they looked at all agencies that used the facility and Morgan City had submitted about 271 cases to the lab, which would equate to \$218,302 of the five-million-dollar match. He requested a resolution of support from the Mayor and Council for the Capital Outlay Request with an agreement to match up to \$218,000 if the Capital Outlay funding was awarded; whereupon,

Mr. Hymel offered the following Resolution, who moved for its adoption.

RESOLUTION NO. R: 22-23

A RESOLUTION IN SUPPORT OF THE ACADIANA CRIMINALISTICS LABORATORY DISTRICT CAPITAL OUTLAY REQUEST FOR FUNDS TO CONSTRUCT AND EQUIP A NEW ACADIANA CRIMINALISTICS LABORATORY; COMMITTING TO PROVIDE MATCHING FUNDS IN AN AMOUNT NOT TO EXCEED \$218,302.00 SHOULD SAID CAPITAL OUTLAY REQUEST BE FUNDED BY THE STATE OF LOUISIANA AND LOCAL MATCHING FUNDS BE REQUIRED; PROVIDING FOR THE EFFECTIVE DATE THEREOF; AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, the Acadiana Criminalistics Laboratory District is a political subdivision of the State of Louisiana operating the Acadiana Criminalistics Laboratory for the purpose of crime detection, prevention, investigation and other related criminal investigative services; and

WHEREAS, the Acadiana Criminalistics Laboratory District boundaries include the parishes of Acadia, Evangeline, Iberia, Lafayette, St. Landry, St. Martin, St. Mary and Vermilion; and

WHEREAS, the current Acadiana Criminalistics Laboratory facility is in need of repairs, expansion and upgrading to meet the increased demand for its services by the law enforcement, prosecutorial, and judicial community; and

WHEREAS, the Acadiana Criminalistics Laboratory District has submitted a Capital Outlay Request to the State of Louisiana for funding to plan, construct and equip a much-needed new Acadiana Criminalistics Laboratory, including office, evidence storage and laboratory space; and

WHEREAS, the new Acadiana Criminalistics Laboratory will be built on an approximately three (3) acre tract of land owned by the Acadiana Criminalistics Laboratory District located adjacent to or near the current Crime Lab facility; and

WHEREAS, the Acadiana Criminalistics Laboratory Project is extremely important to the health, safety and welfare of the citizens of the Acadiana Region; and

WHEREAS, most Capital Outlay Requests require some level of local matching funds; and

WHEREAS, the City Council of Morgan City wishes to express its full and complete support of the Acadiana Criminalistics Laboratory District Capital Outlay Request and its commitment to provide its pro-rata share of any required matching funds should the Request be funded.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Morgan City hereby expresses its full and complete support of the Acadiana Criminalistics Laboratory District Capital Outlay Request to the State of Louisiana for funding to plan, construct and equip a new Acadiana Criminalistics Laboratory to be located on land owned by the District located adjacent to or near the current Acadiana Criminalistics Laboratory facility.

BE IT FURTHER RESOLVED, that the City Council of Morgan City also commits to cooperate with the Administrative Branch of the City of Morgan City to use their best efforts to provide funding of up to \$218,302.00 should the Capital Outlay Request made by the Acadiana Criminalistics Laboratory District be funded by the State of Louisiana and local matching funds required.

BE IT FINALLY RESOLVED, that this Resolution shall become effective immediately upon adoption by the City Council of Morgan City and approval by the Mayor.

Ms. Hailee Thomas with the Louisiana Shrimp & Petroleum Festival submitted the annual festival request (copy on file). A motion to approve the 87th Louisiana Shrimp & Petroleum Festival was made by Mr. Domangue, seconded by Mr. Stephens and voted unanimously in favor.

Mrs. Ruby Maize, Mr. Courtney Long and Mrs. Danika Foley Long with the Juneteenth Committee submitted a request to hold the 2022 Juneteenth celebration on Saturday, June 18, 2022, beginning at Jimmy Johnson Memorial Park at 8:00 AM. A motion to approve the Juneteenth celebration and bike ride was made by Mr. Hymel, seconded by Mr. Domangue, and voted unanimously in favor.

Mrs. Sadie Rankin, Main Street Director, submitted a request to hold the Fourth of July celebration at Lawrence Park on Saturday July 2, 2022. She stated that bands would begin at 4 PM with a fireworks show on the Atchafalaya River at 9 PM. A motion to approve

the July 4th event was made by Mr. Stephens, seconded by Mr. Domangue, and voted unanimously in favor.

Chief James Blair stated that after 30 years with the Morgan City Police Department he had decided to retire effective May 31, 2022. He read his resignation letter into record (copy on file) and he thanked the Mayor and Council for their support through his tenure as Chief.

The minutes of the April 26, 2022 meeting were submitted. There being no corrections, additions, or deletions, a motion to approve the minutes was made by Mr. Domangue, seconded by Mr. Hymel, and voted unanimously in favor.

Mrs. Deborah Garber, Finance Director, submitted the following financial statement for the period ending April 30, 2022.

budget for the period ended April 30, 2022.

Attached is a summary that compares our actual revenues and expenses to our operational budget for our major funds subject to budgetary control for the period ending April 30, 2022. The following comments are related thereto:

General and Ancillary Funds: The actual total revenues remain over budget by \$540,481. Sales taxes in General Fund were over budget by \$166,000, dividend from workmen's compensation was over budget by \$100,000, and Lake End Park is over budget in revenues by \$129,000. Operating expenses are below budget by \$349,752. The net income, after transfers, of \$212,598 is a favorable variance of \$1,000,233 compared to the budget.

<u>Utility Fund</u>: Actual revenues are currently over budget by \$143,039. The operational expenses are under budget by \$350,809. The net income, after transfers, of \$16,081 creates a favorable variance of \$559,273 which is very similar to last month.

<u>Sanitation and Sewer Fund</u>: The operating revenues are \$1,417 over budget, with total operating expenses under budget by \$60,015. The net income, after transfers, of \$413,495 leaves another favorable variance of \$61,685.

A motion to accept the financial statement was made by Mr. Tamporello, seconded by Mr. Hymel, and voted unanimously in favor.

Mr. Anthony Governale submitted his annual progress report on Flood Damage Prevention (copy on file).

The next matter on the agenda was the Freeboard Adoption of Chapter 26 Floods. This was a first reading; no definitive action was necessary.

In the condemnation and demolition reports, Mr. Pete Lawton stated that he had gotten no response from Creuder Investments, the owners of 713 and 715 Fourth Street. A motion to approve the condemnation and demolition of the duplex located at 713 and 715 Fourth Street was made by Mr. Stephens, seconded by Mr. Domangue, and voted unanimously in favor.

Mr. Lawton stated that he had been in contact with the owners of the house at 122 Oak Street. He asked that the Council table this for now. A motion to approve the condemnation and demolition of 128 Oak Street and 104 Mount Street and to table the condemnation of 122 Oak Street was made by Mr. Domangue, seconded by Mr. Hymel, and voted unanimously in favor.

The next matter on the agenda was the resolution calling for a Special Election for the sales and use tax renewal, whereupon,

The following resolution was offered by Mr. Hymel and seconded by Mr. Tamporello:

RESOLUTION NO. R: 22-24

A resolution ordering and calling a special election to be held in the City of Morgan City, State of Louisiana, to authorize the renewal of a sales and use tax therein; making application to the State Bond Commission; and providing for other matters in connection therewith.

BE IT RESOLVED, by the Morgan City Council (the "Governing Authority"), acting as the governing authority of the City of Morgan City, State of Louisiana (the "City"), that"

SECTION 1. <u>Election Call.</u> Subject to the approval of the State Bond Commission, and under the authority conferred by the Constitution of the State of Louisiana of 1974, including Article VI, Section 29 thereof, the applicable provisions of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the City on **TUESDAY, NOVEMBER 8, 2022**, between the hours of six o'clock (6:00) a.m. and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the sad election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

SALES TAX RENEWAL PROPOSITION

Shall the City of Morgan City, State of Louisiana (the "City"), be authorized to continue to levy a tax of three tenths of one percent (3/10%) (the "Tax") (an estimated \$790,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of twelve (12) years, beginning January 1, 2024, upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the City, as defined by law, with the avails or proceeds of the Tax, after paying the reasonable and necessary expenses of administering and collecting the Tax, to be dedicated, and used for the purpose of paying the cost of constructing, improving, resurfacing, maintaining and providing street drainage for public streets, alleys, sidewalks and public wharves, and acquiring equipment therefor?

SECTION 2. <u>Publication of Notice of Election</u>. A Notice of Special Election shall be published in the official journal of the City once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full.

Notwithstanding the foregoing, prior to the publication of the Notice of Election, the Mayor is authorized and directed to make any amendments to the foregoing proposition that may be required to comply with any state or federal regulatory agencies.

SECTION 3. <u>Canvass.</u> This Governing Authority shall meet at its regular meeting place, the City Court Building, 7261 Hwy. 182 East, Morgan City, Louisiana, on **TUESDAY**, **DECEMBER 20, 2022**, at **SIX O'CLOCK (6:00) P.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.

SECTION 4. <u>Polling Places.</u> The polling places for the precincts set forth in the aforesaid Notice of Special Election are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. <u>Election Commissioners: Voting Machines.</u> The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor ass may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held as provided in Section 3 hereof. All registered voters in the City will be entitled to vote at the special election, and voting machines shall be used.

SECTION 6. <u>Authorization of Officers.</u> The Clerk of the City is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia

essential to the proper holding of said election and the Mayor and/or City Clerk of the City are further authorized, empowered and directed to take any and all further action required by the State and/or Federal law to arrange for the election.

SECTION 7. <u>Furnishing Election Call to Election Officials.</u> Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines of St. Mary Parish and the Registrar of Voters of St. Mary Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. Application to State Bond Commission. Application is made to the State Bond Commission for consent and authority to hold the special election as herein provided and, in the event said election carries, for further consent and authority to continue to levy and collect the sales and use tax provided for therein. A certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application.

ORDINANCE NO. 22-03

AN ORDINANCE FIXING THE RATES OF TAX TO BE ASSESSED BY THE MUNICIPAL CORPORATION OF MORGAN CITY, LOUISIANA, FOR THE CALENDAR YEAR 2022.

BE IT ORDAINED, by the City Council, the governing authority of the City of Morgan City, Louisiana, in regular session convened:

SECTION 1

That the tax roll of the City of Morgan City as prepared by the St. Mary Parish Assessor, showing the assessed value of all property subject to taxation within the said City, on said roll, to amount to the sum of ONE HUNDRED THIRTY-FOUR MILLION, ONE HUNDRED TWENTY-THREE THOUSAND, NINE HUNDRED TWENTY-NINE and no/100 DOLLARS (\$134,123,929) to be and the same is hereby ratified and approved by this body.

SECTION 2

That for the purpose of meeting the ordinary, municipal expenses of said City for the year 2022 there is hereby levied upon all property within said City, subject to taxation, an ad valorem tax of SIXTEEN AND SEVEN ONE HUNDREDTHS (16.07) mills on the dollar, upon the assessed value of ONE HUNDRED THIRTY-FOUR MILLION, ONE HUNDRED TWENTY-THREE THOUSAND, NINE HUNDRED TWENTY-NINE and no/100 DOLLARS (\$134,123,929)

SECTION 3

That for the purpose of paying the maintenance and other such expenses of the Municipal Auditorium for the year 2022, there is hereby levied a tax of TWO (2.0) mills on the dollar upon the

assessed value of ONE HUNDRED THIRTY-FOUR MILLION, ONE HUNDRED TWENTY-THREE THOUSAND, NINE HUNDRED TWENTY-NINE and no/100 DOLLARS (\$134,123,929

SECTION 4

That the City Tax Collector of the City of Morgan City, Louisiana, be and he is hereby authorized, empowered, and directed to make the collection of the taxes imposed for and on behalf of said City, according to law; that the taxes herein levied shall be a permanent lien and privilege on all of the property subject to taxation as herein set forth; and the collection hereof shall be enforceable in the manner provided by law.

SECTION 5

That all ordinances or parts of ordinances in conflict hereby be and the same are hereby repealed and this ordinance shall take effect upon its adoption, the public welfare so demanding.
